## **2010 Merrimack Valley Skating Club ~Summer Freestyle, Yoga Class & Power Skating Class~**

**June 21<sup>st</sup> – August 19<sup>th</sup>**

**Merrimack Valley SC members will receive priority until June 7<sup>th</sup>. After June 7<sup>th</sup> non-member applications will be accepted. After July 8<sup>th</sup> skaters will pay the walk-on fee for ice and will not be eligible for the contracted price.**

Tentative walk-on ice: August 24<sup>th</sup> & 26<sup>th</sup> (9-10am Freestyle & 10-11am Freestyle)**

This ice is available to figure skaters who are receiving private lessons and/or taking part in practice sessions. Skaters may do Dance and Moves on all sessions offered. It is recommended that each skater has passed at least the USFS Basic 3 level before they use this ice. Please contact the Skating Director, Nikki Roberts, for information regarding which session would be most appropriate for your skater. Nikki may be contacted in order to find a private coach. Coaches who are interested in teaching on this ice (and during weekly Public Skating sessions) must be approved by North Shore Rink Management. Applications to coach at the Graf Rink may be obtained in the front office.

A 50% deposit is due with your registration. Your final payment is due no later than July 15, 2010. **Please note that there will now be a 5% finance charge applied to all late balances each week past the due date.** Skaters will not be allowed to contract future sessions until their balances are paid in full. Skaters must check in with Nikki before taking the ice. As a courtesy, please call the rink ahead of time if you will be missing a session. There will be a limit of 20 contracted skaters allowed on each session. Walk-on skaters will be allowed if space permits due to cancellations and will be charged an additional \$2 per each session skated. Skaters must pay for walk-on sessions before they get on the ice. There will be no exceptions to this rule and no bills for walk-ons will be sent. Checks should be made payable to MVSC (Merrimack Valley Skating Club) and, if paying with cash, exact change is greatly appreciated.

- 1.) That skating and off-ice conditioning (dry land training) is a participation sport and I am fully aware of the risks and hazards involved in or arising from my use or presence upon the facilities. I hereby assume any and all risks involved in or arising from my use of our presence upon the facilities, including, without limitation, the risks of bodily injury resulting from collision between myself and another person or a stationary object or the negligent or deliberate act of another person:

To release NSRM and/or MVSC and all of its successors, assigns, affiliates, officers, directors, instructors, employees and agents from, and agree not to sue any or all of them on account of or in connection with any claims; causes of action, injuries, damages, costs or expenses arising out of Skater's use of or presence upon the Facilities, including, but not limited to, those based on bodily injury, whether or not caused by the negligence or other fault of NSRM and/or MVSC.
- 3.) This release shall be binding upon my heirs, administrators, executors, assigns and legal representative.

To waive the protection afforded by any statute or law in any jurisdiction whose purpose, substance and/or effect is to provide that a general release shall not extend to claims, material or otherwise, which the person giving the release does not know or suspect to exist at the time of executing the release.
- 5.) If I ignore this agreement and file suite, I will be held responsible for all attorney fees and court costs incurred by NSRM and/or MVSC.
- 6.) I have read and understand this agreement. I understand that by signing this agreement I surrender valuable rights, including, but not limited to, my right to sue. I do so waive voluntarily.
