Basic Class Information

Children must be at least 3 years old and have close to a 50 minute attention span. Each Tiny Tots class consists of a 5-minute group warm-up, a 30-minute lesson (divided into classes) and concludes with a 15-minute on-ice game involving all skaters. If your skater has aged out of the Tiny Tots program there is a Basic Skills (Learn to Skate) program run by the Graf Rink as well. Basic Skills classes meet on Thursday at 6pm as well as Sunday at 4pm and 5pm. There are also a limited number of Tiny Tots spaces during these classes for skaters who can't make the weekly Tiny Tots classes. Applications are available online at www.grafrink.com or on the Graf Rink bulletin board. **Pre-registration is mandatory.** Your payment is due in full with your registration. Please read the full refund policy below. The deadline to register is September 6th. Applications are taken on a first come basis and **only until space no longer permits. Confirmation calls will not be made.** You will only be notified if there were not enough applications received for a certain class time. Classes are taught by the Graf Rink professional coaching staff. All coaches have successfully completed a comprehensive background screening process through the

National Center for Safety Initiatives.

Equipment

Double runner blades are not allowed. Skates may be rented for \$3 each week in our pro-shop if you do not have your own. We strongly recommend using figure skates when learning how to skate for the first time. When this is done, skaters who want to transition into hockey skates may do so after they learn how to stand up and skate across the ice on their own. Skate-Aides (red bars) are provided by the rink should a new skater need the additional support on the ice. Instructors will distribute the Skate-Aides when necessary and will be used at their discretion. Skaters should be dressed warm and hands should be protected with gloves or mittens. During the cold months most skaters will wear snow suits. Elbow and knee pads are not recommended as they limit mobility. **Helmets must be worn.** Hockey helmets are strongly recommended however a bike or ski helmet is acceptable as long as it fits tight to the head. The Graf Rink sells excellent beginner figure skates at reasonable prices. Please visit the Pro-Shop inside the rink lobby for more information. Tights, gloves, skating outfits and other fun skating supplies may also be purchased in the Pro-Shop.

Requirements

Parents must stay in the lobby or in the bleachers inside the rink. We ask that parents do not stand in front of the boards inside the rink. This makes it very difficult for the coaches to hold the attention of the skaters. At no point in time should you leave your child unattended at the rink. Parents are expected to remain on rink grounds during Tiny Tots classes. If you need to leave however, we ask that you place another parent in charge of your child (in case of an emergency or needed trip to the bathroom) and notify the instructors that you will be leaving.

Parents are not allowed on the ice with the children. Skaters are asked to be on time as late arrivals disrupt the class very easily.
