**Full Membership (Home Club Membership)**

The Home Club is the club who issues the USFS registration card to the member and is the club represented when testing and competing. All test candidates, competitors and guests of other clubs must be a member in good standing with their Home Club and have approval from a Club Official to participate in USFS sanctioned events with MVSC.

**Any skater who wishes to test or compete, and is under the age of 18, must be a Full member of MVSC.**

Full membership in the Merrimack Valley Skating Club entitles the member to represent MVSC at competitions and tests, priority status for test sessions and shows/exhibitions. MVSC will be your home club. Members will receive a subscription to Skating Magazine (one per family), a US Figure Skating registration number and certificates of accomplishment for passing proficiency tests and placing at USFS qualifying events. Full members are entitled to vote on all ballot issues. If the member is under the age of 18, one parent or guardian will be the voting representative for the member.

**Basic Adult Membership (Home Club Membership)**

Basic Adult membership in the Merrimack Valley Skating Club is ideal for any adult skater who requires membership due to USFS compliance, testing and competing. **Basic Adult members must be at least 25 years of age.**

**Associate Membership**

Associate membership in the Merrimack Valley Skating Club entitles the member to priority status for MVSC test sessions and shows/exhibitions. Associate members do not receive USFS registration numbers through MVSC. **MVSC will not be your home club.**

**Social Membership**

Social membership in the Merrimack Valley Skating Club is for individuals who wish to support figure skating and MVSC. Skating professionals are included in this category.

**\*A home club membership (Full, Basic Adult or Social) is required for all MVSC officers and board members.\***

**All categories of MVSC membership will receive seasonal ice schedules for the Graf Rink, notification of upcoming test sessions, shows and exhibitions.**

**Please note: You may join MVSC at any point in time throughout the 2009-2010 season. You will be charged a pro-rated fee beginning with the month that you join.**
